1. Introduction

Greg Smith MP opened the meeting and explained that its purpose was to reduce the number of officers of the APPG from its current eleven to four. One of these officers had to be from the governing party and one officer from the main opposition. The rules stated that this APPG rule be implemented by 31 March 2024 or the group be de-registered.

2. Reduction of officers to four

Greg Smith MP explained that new APPG rules also mean that MPs may only be an officer on six APPGs and that this may have a bearing on several groups. Theresa Villiers MP added that the new rules about the number of APPGs MPs may be an officer of only applies from the start of the next Parliament.
