1. Introduction – purpose of proposed Group (Ed Davey):

The Parliamentarians present agreed to establish the All-Party Parliamentary Group on the Loan Charge.

The purpose of the APPG was agreed as:

The All Party Parliamentary Loan Charge Group exists to raise concerns about the 2019 Loan Charge, which will affect thousands of freelance, contract and locum workers in the UK as well as the wider context of fairness of tax legislation and the conduct of Her Majesty's Revenue and Customs.

2. Election of Officers

Appointment of Secretariat

It was agreed to formally appoint the Loan Charge Action Group as the Secretariat of the APPG.

3. Suggested initial programme of activity

The following initial programme of activity was proposed and approved:

1. An urgent (public) letter from the APPG to HMT re the Loan Charge review laying out what it must review, ask and find out.

Secretariat to draft and send to Chair for approval.

2. A letter to HMRC challenging them on the fact that some of their own contractors are subject to the Loan Charge.

Secretariat to draft and send to Chair for approval.

3. APPG inquiry into the Loan Charge (which needs to report by mid-March to feed into the Treasury review).

Chair and Secretariat to liaise over dates and circulate and to write the terms of inquiry.

4. Other issues mentioned

- Liz Twist requested that the human impact of the Loan Charge be stressed.
- It was suggested that the APPG inquiry could liaise with both the Lords Economic Affairs Select Committee and the Treasury Select Committee.

Chair to write to both, Secretariat to prepare the letter.
