1. Review and approval of the previous APPG's Income and Expenditure Statement

5. Purpose of proposed Group:

The purpose of the APPG was agreed to be kept the same as the previous APPG:

The All Party Parliamentary Loan Charge Group exists to raise concerns about the 2019 Loan Charge, which will affect thousands of freelance, contract and locum workers in the UK as well as the wider context of fairness of tax legislation and the conduct of Her Majesty's Revenue and Customs.

6. Suggested initial programme of activity

The following initial programme of activity was proposed and approved:

i. Secretariat to prepare and circulate a briefing on the Sir Amyas Morse review

Secretariat to prepare and send to APPG members

ii. The APPG will take evidence regarding on the Sir Amyas Morse Review and the government's response to examine where it does and does not adequately address the issues and concerns with the Loan Charge

Officers and Secretariat to identify suitable dates and witness availability for meetings

iii. Press for a full debate on the Sir Amyas Morse report in the main chamber

Officers to make an approach to the Backbench Business Committee

7. Other issues mentioned

- The changes to the Loan Charge announced by the Treasury were briefly discussed including the need for new legislation. It is not clear if this will be part of the next Finance Act or separate. It may be possible to influence this legislation if there is enough support from MPs.
- Parliamentary questions from a large number of MP's would be desirable to ensure the topic continues to have a high profile.
